Top Women in Security ASEAN Region Awards 2023 8 March – 30 May 2023

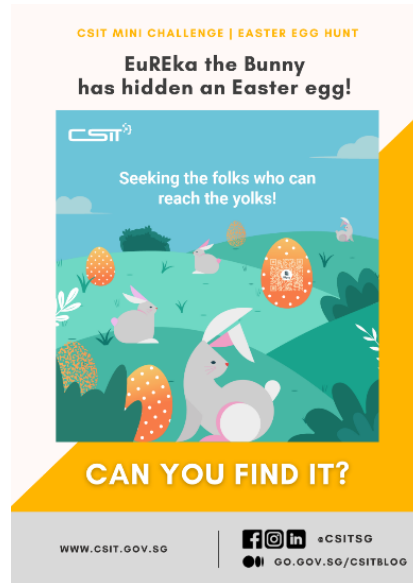
