# Launch of the Association of Information Security Professionals (AISP)'s Legal Investigative Technology Experts (LITE) Special Interest Group at the Inaugural Legal Investigative Technology Experts (LITE) Conference 2025

Singapore, 08 April 2025 – The Association of Information Security Professionals (AiSP) organised the Inaugural Legal Investigative Technology Experts (LITE) Conference 2025 as part of the initiatives by its new Legal Investigative Technology Experts (LITE) Special Interest Group (SIG). Through keynote presentations, and expert panels, participants gained insights into how innovative tools and practices were shaping the future of digital investigations. The conference addressed critical issues such as the legal admissibility of digital evidence, ensuring compliance with privacy laws, and managing the ethical considerations involved in using high-tech solutions for investigations. It provided a distinctive platform for legal professionals, law enforcement, forensic experts, and technology innovators to connect, collaborate, and exchange insights on utilising advanced investigative tools, software, and methodologies. Key topics included digital forensics, e-discovery, data privacy, cybersecurity, Al in investigations, blockchain technology, and the adoption of emerging technologies within legal frameworks. More than 100 guests from the industry, public sector and overseas information security associations attended.

MOS Rahayu also launched the Legal Investigative Technology Experts (LITE) Special Interest Group (SIG). The interest group aims to provide a platform for AiSP members who are interested in Legal Investigative Technology to learn and exchange ideas with other members and experts on this emerging technology. The group also serves as a collaborative platform that brings together private sector organizations (including law firms), government agencies, and educational institutions to share knowledge and expertise in the collective effort to combat digital crimes.

AiSP Legal Investigative Technology Experts (LITE) SIG Lead, Mr Daniel Wang shared, "It is important to prioritize collaboration across different sectors. Digital crimes are increasingly sophisticated and constantly evolving, which means no single sector can tackle the issue alone. By having strong partnerships and knowledge sharing, we can collectively build more



robust defenses, stay ahead of emerging threats, and create a unified response to the challenges of the digital world".
